Subject: Creation of database of Health Care Workers (HCWs) for COVID-19 vaccination.

Sir/Madam,

The Department of Health & Family Welfare has received D.O. no. 1920764/2020/IMMUNIZATION, dated: 16th October 2020 from Sh. Rajesh Bhushan, Secy.(H&FW) GOI, wherein it has been communicated that, as a preparatory activity for introduction of COVID-19 vaccine, MoHFW GOI is preparing the database of Healthcare Workers, which includes healthcare service providers and other workers, in both Govt. and Private healthcare facilities. **The HCWs are to be prioritized for receiving the COVID-19 vaccine and in this regard the NCT of Delhi is expected to create a database of HCWs in a prescribed excel template.**

State MD (NHM) has been designated as the Nodal Officer at State Level and the DM/DCs have been made incharge of the activity at district level. **The districts have been directed to ensure that every facility (Govt. & Private) in their district fills the details as per the standard template and submit the same back to the district by 25th October 2020.**

After receipt of the complete data set from all facilities, the districts are to upload the templates on COVID-19 Vaccination Beneficiary Management System (CVBMS) which is currently under development by Govt. of India. The guidelines for uploading the data on CVBMS will be shared by GOI shortly.


The districts have been further directed to ensure that the facility wise data is compiled and saved in dedicated folders as is prescribed in the guidelines, by 31st October, 2020.

The MoHFW, GOI has designated UNDP as the Co-ordinating Agency for this drive.

In this regard, it is requested that all medical professionals running stand alone/single doctor clinics may be informed/directed to contact their concerned district officers for incorporating their details in the data base of Health Care Workers being created for COVID-19 vaccination.

This is for your kind information and prompt necessary action at your end.
